Terms and Conditions

A. Table Space

1. Detroit Fanfare® will provide a 10'x10' booth area to exhibit in with (1) 8' table, (2) chairs and (2) badges for each 10 x 10 booth.
2. All additional equipment and furnishings are the responsibility of the Exhibitor. You may provide your own furnishings.
3. Electrical services can be ordered through Cobo Hall. Exhibitors are responsible for their own services. Please remember to order in a timely manner. Ordering of electrical needs is not the responsibility of Detroit Fanfare®.
4. Detroit Fanfare® reserves the right to change booth locations at the promoter's discretion.
5. Renting, Selling or Subletting booth space is strictly prohibited.

B. Payment for Space

1. Exhibitor understands the payment policy and agrees to pay as per the terms of the application.
2. There will be a \$50.00 fee for checks returned unpaid.
3. Detroit Fanfare requires a **50% deposit** to hold a booth until the early bird payment date of 8/1/2011. If full payment is not made by this date you are no longer entitled to the reduced rate. If you fail to make full payment by **September 24th** it will result in the loss of your exhibitor space.
4. All deposits are non-refundable.

C. Display Regulations

1. Exhibitors must be sure that all noise levels from sound systems are kept to a minimum. Detroit Fanfare® reserves the right to determine at what point that noise level constitutes interference with others and must be discontinued.
2. No exhibit may block or interfere with other exhibits and may not exceed booth space or 8' high.
3. Any damage caused to the building or its furnishings by the Exhibitor are the sole responsibility of the Exhibitor.
4. Exhibitor agrees to remain set up during all exhibit hours. No early breakdowns of exhibits are allowed without the prior consent of the show promoters.
5. Exhibitors must stay within the boundaries of their exhibit space.

D. Merchandise for Sale

1. Dealer agrees that all merchandise for sale is legal and licensed.
2. Bootleg merchandise is prohibited and the promoter is not responsible but will take action if necessary.
3. **ABSOLUTLY NO PORNOGRAPHY OR ADULT ONLY MATERIAL IS TO BE DISPLAYED AT ANY TIME.**
4. Dealer agrees not to sell or distribute any adult material to minors. All Adults Only material must be either behind the table or, if displayed on a table or display rack, bagged or covered so that minors may not open it. Any adult material depicting nudity must be "blinded" (i.e. the nudity or sexual conduct must be completely covered).
5. Adult video tapes and DVD's **are not** allowed at all.

E. Taxes and Licenses

1. Dealers shall obtain any licenses, permits, identification numbers, or approvals under federal, state or local law applicable to its activities at the event at its sole expense including the Michigan State sales tax.
2. Dealers not holding a State of Michigan sales tax license agree to file a Concessionaire's Sales Tax Return within 3 days after the end of the con. We will provide you with this form.
3. Dealer understands that failure to file a Concessionaire's Sales Tax Return may result in a tax assessment against you by the Revenue Commissioner.

F. Damages & Losses

1. Promoter will provide on-site security. However Exhibitor accepts full responsibility for any damages to your booth or merchandise for any reason. Promoter is not responsible for any loss.
2. Dealer is responsible for their own security during show hours.

G. Cancellation

1. No refunds will be given if exhibitor cancels. A one year transfer will be granted and payment will be applied to the next show.
2. Promoter agrees to refund all booth fees within 30 days if the event is canceled for any reason.

H. HOLD HARMLESS

By signing agreement, you acknowledge that you have read, understand and agree to be bound by both the terms and conditions set on this application. You acknowledge that failure to abide by the rules may result in the loss of your Exhibitor privileges without recourse or refund. By agreeing to exhibit at Detroit Fanfare®, the exhibitor agrees to protect, keep and save the Detroit Fanfare® promoter and Cobo Hall forever harmless from any damage, loss, theft, cost, liability, act of god, terrorism or expense that arises from their exhibiting at this show. This agreement covers full setup, run of the show and tear down.
